## How Should ECO BRAN Be Applied in Smaller Settings?

ECO BRAN is easily applied using a hand held shaker spreader such as one used for spreading fertilizer or grass seed. It is recommended to follow all label instructions regarding safety precautions when applying.

### How does ECO BRAN work?

Eco Bran is a bait formulated product which contains an attractant. We recommend "sprinkling" Eco Bran around the perimeters of crops to attract target insect pests away from crops.

### Can I use ECO BRAN if I have pets?

As an insecticide bait ECO BRAN has to be consumed in order to have any negative impact. Its impact is based on consumption by body weight. Grasshoppers and crickets are substantially smaller than dogs and cats. Dogs and cats are not drawn to ECO BRAN and it is not a desirable food source for them. Even then a large, extensive amount would have to be consumed to be of any concern.

### **Domestic Birds and ECO BRAN**

ECO BRAN should not be applied where captive or livestock poultry have access to the product. Not only will the chickens or other poultry livestock eat the ECO BRAN (making it ineffective and not available to kill target pests) but it will also not be beneficial to the birds. Eggs and meat should not be eaten from chickens if they have eaten ECO BRAN recently.
